

# Water pipe burst incident report

Statement Regarding Absentee Ballot  
Tabulation at State Farm Arena

An approximately 6:07 a.m., the staff at State Farm Arena notified Fulton County Registration & Election of a water leak affecting the room where absentee ballots were being tabulated. The room was evacuated and the water was turned off. The tabulation process was suspended until complete. No ballots were damaged nor was any equipment affected. There was a short delay in counting the ballots. Fulton County will now count the approximately 81,000 absentee ballots, as well as Fulton County's early voting results. These represent the vast majority of ballots cast within Fulton County.

Fulton County did not anticipate having all absentee ballots processed on Election Day. Fulton County is committed to ensuring that every vote is counted and will comply with all applicable laws and regulations.
